Sliding Fee Scale

Individuals and families with income at or below 100% of the federal poverty guidelines and do not have access to Region funding assistance or probation vouchers qualify for services at no cost.

The sliding fee scale is available for individuals and families that are above 100% and at or below 200% of the federal poverty guidelines and do not have access to Region funding assistance or probation vouchers.

Treatment services eligible for the sliding fee scale include: Community Support, Individual Counseling, Group Counseling, Intensive Outpatient Program (IOP), Substance Use Disorder Assessment, and Initial Diagnostic Interview. Additionally: Targeted Case Management, Community Treatment Aide, Psychological Testing, Assertive Community Treatment, & Supported Employment.
